Going back to fixed routes we may want to have first aid kits, and nasal Narcan available.

Tony Tollefson will not be able to stop in and sign checks on the 27th. He would like Bill to let people know when he is out of town. He can do this by setting up a phone message on the new phone system. Discussed some comments his wife saw on Facebook. And some issues with dispatch.

Jim Nankervis received a letter from Chocolay Township about their Master Plan discussing Marq- Tran.
